## **Corporation Board and EIAAA to Merge**

The Corporation Board and the Eastern Iowa Acacia Alumni Association are combining several offices to facilitate consistent communication with alumni. Acacia's return requires planning, money and volunteers. This change allows discussion within a common framework, while each organization continues to serve its stated purpose.

Harold Zarr, an Iowa State Acacian, has accepted the role of Corporation Board President. Harold is actively involved with the Iowa State Chapter and played a crucial role in the successful re-colonization at Ames. Harold has graciously agreed to serve while Iowa attempts to recreate ISU's success.

Aaron Morrow, current EIAAA president, has accepted the role of board Vice President. Brian White, current EIAAA secretary, will take over as Corporation Board Secretary. Dan Wilkes will stay on as Building Manager and Treasurer of the Corporation Board. He will oversee finance and renovation planning.

Two additional positions will be discussed. The first proposal is for an

Alumni Chair. This position will oversee social events, and act as President of the EIAAA. The second position will act as EIAAA treasurer in charge of dues and finances of the EIAAA fund.

A quarterly newsletter will continue to be produced as well as spring (Nile) and fall (Tailgate) social events. The newsletter and social events are an opportunity to stay in touch with our brothers, chapter and the University of Iowa. We hope these efforts encourage greater participation as we work to re-establish Acacia Fraternity at Iowa.

The chapter house is currently leased to Pi Kappa Phi fraternity, and managed by Keystone Property Management. The most recent improvement involved the installation of electric radiant heating units to replace the boiler. This project was paid with additional borrowing against the property. A cash reserve was also established while we consider additional projects to cure deferred maintenance. Projects have not yet been prioritized, but include exterior repair to the columns and fascia as well as a kitchen remodel.
