ACACIA Returns to the University of Iowa

In June 2010, the journey will begin again. Two graduate students will begin a two year mission. The applicants will come from Acacia Chapters all across the country, each one possessing an impressive resume. Two young men will be chosen from this pool of applicants, provided by the International Council of the Acacia Fraternity and hand-selected by the Acacia Corporation Board and Alumni. These two leaders will be changing the face of the Greek System at Iowa. They will be leading the reformation of the Iowa Chapter of the ACACIA Fraternity.

The pledge recruitment process will begin during the summer, utilizing a scholarship program funded by the donations of University of Iowa Acacia Alumni. This program helps to identify incoming freshmen that are already leaders. This informal recruitment period during the summer will turn into the formal recruitment sponsored by the University during the week before classes begin.

Once a pledge class is formed, the two graduate students will begin administering the New Member Education Plan, Cornerstones. This pledge class will then begin working with the graduate students towards initiation into the ACACIA Fraternity and the reformation of the Iowa Chapter. Each semester will see an increase in membership, brotherhood, and a continuation towards the final goal: reestablishment of the Active Chapter of Acacia and occupation of the Acacia Chapter House at 202 Ellis Avenue.

This vision can only become reality with **YOUR** help. The Iowa Acacia Corporation Board and the Eastern Iowa Alumni Association are beginning a three year fundraising drive to raise \$100,000 – funds that will bring the ACACIA Fraternity BACK to the University of Iowa Campus. Our future members need your assistance. Please choose an

amount that you can donate in the years 2008, 2009, and 2010. Your tax-deductible donation should be made to The Acacia Fraternity Foundation: Iowa Chapter Fund. These donations will be used to provide the scholarships to the two graduate students who will be working towards our goal of returning to campus, and will help fund the Iowa Acacia Leadership Scholarship as a recruiting tool for incoming freshmen at the University of Iowa.

Chapter Eternal – James Gines #414

James Peter Gines, age 71 years, passed away on Thursday, March 22, 2007, in Cape Canaveral, Florida, while on an annual golf trip with the "Guys from Ford." J. P. was born on January 15, 1936, in Minneapolis, Minnesota, the only child of Joseph Carrancho Gines and his wife Agnes Marie Grimstad. In 1940, the family moved to the river town of Iowa Falls, Iowa, and there Jim graduated from

Iowa Falls High School in 1954. He had competed in varsity football, basketball, and All State Track. J. P. graduated from the University of Iowa, in 1960, with a Bachelor's Degree in Electrical Engineering. During his college years, Jim worked part-time as a disk jockey with the "on air" name "Tiger." This would remain his nickname by old high school and college friends the remainder of his life.

Jim was affiliated with the Acacia Fraternity and was a former member of the Elks Club. Following graduation, Jim went to work for ITT, the Kellogg Switchboard Division, in Chicago, on the radio equipment installed in the first space capsules. It was an exciting time to be an Engineer. On September 4, 1960, J.P. was married to Kay Ruby Maxwell, in Dexter, Iowa, and to this union, two daughters were born, Kristina Kay and Katherine Kolleen. In 1962, J. P. took a leave of absence to return to the University of Iowa, earning an MBA. Jim had grown up in a FORD family and 1966 found him accepting a position with the Product Planning Division of Ford Motor Company in Dearborn, and the family

moved to Ann Arbor. He would spend the next 35 years with Ford, retiring in 2001.

In 1989, Jim and Kay moved to Melbourne, Victoria, Australia, when Jim took a Foreign Service Assignment to work on the Quality of the Capri. He fell in love with Australia, and had been able to return three times after his assignment. Coming home to the States, he spent two years in Benicia, California, doing Quality at the Port of Entry. He returned to Dearborn and Ann Arbor in 1994, and there he would remain until his retirement. He loved Ann Arbor, it was a Big Ten Town!!! And he only had a problem when the Wolverines met the Hawkeyes!!! Jim was a member of Trinity Lutheran Church. He had served on the Vestry, many committees, and spent years as a Head Usher of his own team. Jim loved the "water," he had been a swimmer since childhood, and in the mid 70's learned to sail, developing a distinct dislike for "stinkpots." Always athletic, he biked competitively in the 70's & 80's with his friend Steve, skied at every opportunity, and was always an "I can do it myself" guy, particularly if it would save him money!!!

He spent his retirement years doing woodworking, having breakfast with the Tuesday Golf Bunch, playing golf and then playing MORE golf, still loved to play the piano, and he always had time for a party and a glass of wine!! Jim was very proud of his daughters; they had inherited both his intellect, and his athletic abilities. Jim and Kay had spent the past three years traveling wherever Kris and Kitty competed as Triathlon Athletes. AND he loved his granddaughters who helped "Pappa" bake cookies. J. P. is preceded in death by his parents and extended family. He is survived by his wife Kay, daughters Kristina (Charles) Farrow of Carlisle, Mass., and Katherine Gines of Chelmsford, Mass., granddaughters Jordan and Davis Farrow, in-laws, cousins, and so many friends who were as close as his family.

Chapter Eternal – Dennis Clark #554

Dennis M. Clark, 56, died Saturday, July 14th of sudden heart failure. Funeral services were held Saturday, July 21, 2007 at St. Augustin Catholic Church. Burial followed at Resthaven Cemetery.

He was a graduate of the University of Iowa, and was the Division Manager of Human Resources for John Deere Agricultural Marketing Center.
