Fundraising Efforts Have Begun

The fundraising efforts have begun. Fifteen Acacia alumni have donated so far in 2008. These fifteen alumni have donated a total of \$2,988 towards the re-colonization effort and another \$825 in voluntary alumni dues. They have also pledged a total of \$4,876 for 2009 and 2010. The money donated to the Acacia Fraternity Foundation (AFF) University of Iowa Chapter Fund is tax deductible and will be used to provide scholarships to Acacia Graduate Students that will help oversee the reformation of the Iowa Chapter of Acacia. The \$75 Annual Voluntary dues are used to help pay for the mailing cost of The RESH newsletter and are also used to help offset the costs of the Spring Social Event and the Fall Homecoming Tailgate.

Inserted in this newsletter you will find a donation card. It's not too late to get on board for 2008 and make your 3-year commitment to the return of Acacia at the University of Iowa. A \$1 per day donation and pledge over the 3 year fund drive totals a \$1000 donation and leaves almost \$30 a

year to use towards a social event like the Golf Outing or to provide a nice case of beer for the Fall Tailgate. The pledge recruitment process will begin during the summer, utilizing a scholarship program funded by the donations of University of Iowa Acacia Alumni. This program helps to identify incoming freshmen that are already leaders. This informal recruitment period during the summer will turn into the formal recruitment sponsored by the University during the week before classes begin.

I would like to thank each of you for your past support and for the future time, energy, and monetary commitments that you can pledge to the Reformation Movement of the Iowa Chapter of the Acacia Fraternity.

Facility Update

Summer time is a great time to get a good look at the property and try to prioritize the projects that need the most attention. The Corporation Board has planned a few projects for this summer and has also discussed some long term plans.

This summer we will be doing work on the exterior and interior of the house. Outside we will be replacing all four top corners of the house. The wood is going bad and starting to deteriorate so we are going to fix them up and replace them. Additionally we will be repainting the front stucco that surrounds the front entrance. In August we will replace the back "deck" areas that lead up to both rear entrances.

Inside the house we are going to be working on floor coverings. Both the front and rear foyers will be getting new carpet as well as the every staircase in the house and 2nd floor hallway. If any of you have been to the house lately you probably noticed how tired the beautiful chapter room floor is looking so we are also going to have that refinished as well.

With the age of our house, it seems as if there is always a huge list of maintenance issues we need and want to take on. Because of this the Corporation board is contemplating using a company named Executive Outcomes to help us itemize and prioritize these projects. Executive Outcomes would come in and go through the house top to bottom and look at every aspect of the property from floor coverings to the security of the house and provide a detailed report as to what needs to be done and in what order.

As always on top of all of these planned improvements there are always ongoing issues with a building this age and those issues are being addressed as they arise. The chapter house is looking better each passing year.

I would like to thank all of you from the bottom of my heart for your tremendous expressions of support during the last months as I have struggled with my health issue. They have meant the world to me.

I have had good news from my doctors in the last two weeks. The oncologist says that there is no need for any more chemo, and only today I learned that my blood test has come up clean, so the chemo, radiation, and surgery have done their work. My surgeon told me today that after two years there is a 90% probability that there will be no recurrence if I'm clean after two years, so I'm six months out of surgery and I have eighteen months more to go.

Throughout the last year my mantra has been "I have to take my life back," so that's what I'm doing. This summer I am teaching in Spain as was the plan even before my unwelcome diagnosis, and at the end I'm going to Paris for a week before I return home.

I am really looking forward to fall trips to Iowa City this year, and want to see all of you there.
